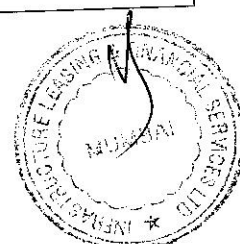



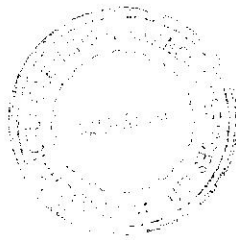

The National Company Law Appellate Tribunal ("NCLAT") has passed an order on October 15, 2018 in the Company Appeal (AT) 346 of 2018 which inter alia restricts actions or proceedings by creditors against the Company and its group companies until further orders.

The moratorium ordered by the NCLAT enables value preservation of the group's assets and will also assist the newly constituted board of directors of the Company in its effort to evaluate and prepare a resolution plan keeping in mind the various stakeholders, including the debentureholders.
